Proposers shall obtain candidates consent for nomination. The Management Committee will make nominations for Vice Presidents; No nominations shall be accepted from the floor of the AGM. Nominations for Vice Presidents can be made by any Full Member in writing to the Secretary at least three days in advance before the meeting.

Field Officers shall be elected by the Management Committee at its first meeting following the AGM

## Clause 4 (b). Management Committee.

Amended to read (alterations highlighted in italics)
The affairs of the Club shall be conducted by a Management Committee consisting of;
(i) Chairman
(ii) Secretary
(iii) Treasurer
(iv) Cricket Development Manager
(v) Ground Manager
(vi) Sussex Cricket League Representative
(vii) Committee Member with the option of co-opting one more if required

Any reference termed as General Committee within the Constitution shall now be described as Management Committee. Other amendments to the Constitution will need to be made by the Management Committee, following the AGM, to reflect the setting up of a number of sub-committees that will assist in the day-to-day management of the Club.
7. To elect a President, Chairman and Other Officers as described in the amendment to Clause 4 (b) of the Constitution.

The Committee will recommend candidates to the AGM, but nominations for any position can be made by any Full Member to the Secretary at least 48 hours in advance of the meeting provided they are supported with a Proposer and Seconder. Nominations from the floor will not be accepted. If more than one nomination is received for any post a paper vote will be held at the meeting.
